Hazardous Identification Information:

The International Agency for Research on Cancer (IARC) lists chlorophenoxy herbicides in its Group 2B (limited evidence for carcinogenicity in humans.) The US EPA has given the chlorophenoxy herbicides 2,4-D, 2,4-DP, MCP, and MCPA a Class D classification (not classifiable as to human carcinogenicity.) More recent 2,4-D lifetime feeding studies in rats and mice did not show carcinogenic effects and a recent World Health Organization (WHO) review of 2,4-D toxicology has concluded that 2,4-D is not a carcinogen.

4. First Aid Measures:

Route(s) of Entry:

Contact, inhalation, ingestion.

Health Hazards (Acute and Chronic):

EYES: May cause mild to moderate irritation.

SKIN: May cause mild to moderate dermal irritation.

INHALATION: May cause mild to moderate respiratory irritation.

INGESTION: May irritate gastrointestinal tract.

CHRONIC: Repeated and/or prolonged overexposure may cause chronic irritation of respiratory tract. Overexposure may cause adverse effects to liver, kidneys, skin, muscular and gastrointestinal systems.

Signs and Symptoms:

Burning sensation; coughing; dizziness.

Medical Conditions Generally Aggravated by Exposure:

Asthma or skin lesions may be aggravated by exposure to this product.

Emergency First Aid Procedure:

If inhaled:

- Move person to fresh air.
- If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth if possible.
- Call a poison control center or doctor for treatment advice.

If on skin or clothing:

- Take off contaminated clothing.
- Rinse skin immediately with plenty of water for 15 - 20 minutes.
- Call a poison control center or doctor for treatment advice.

If in eyes:

- Hold eye open and rinse slowly and gently with water for 15 - 20 minutes.
- Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye.

Fire Extinguishing Media:

Foam, CO₂, Dry chemical, Water. The low flash point of this product is due to a minor component in the mixture. Based on independent laboratory testing of similar products, this product would not sustain combustion as specified in DOT Regulation 49 CFR 173 Appendix H, and, therefore, would not be classified as a combustible liquid.

Special Fire Fighting Procedures:

Wear positive pressure breathing apparatus and full protective clothing.

Unusual Fire and Explosion:

Burning product may produce irritating or poisonous gases. Runoff from fire control area or dilution water may cause pollution. If surface water is contaminated, contact local authorities.

6. Accidental Release Measures:

Steps to be Taken in Case Material is Released or Spilled:

Do not touch spilled product. See Section 8 for Personal Protective Equipment. Contain spill and absorb onto inert absorbent such as Dri-Rite, sand or pet litter. Collect into drums; cover and label drums for proper disposal. Flush area with water if possible.

7. Handling and Storage:

Precautions to be Taken:

Keep from freezing. Store in original container in a locked storage area inaccessible to children and pets. Do not store near food or feedstuffs.

Other Precautions:

Containers over 1 gallon and less than 5 gallons: Persons engaged in open pouring of this product must also wear coveralls or a chemical resistant apron.

Containers of 5 gallons or more in capacity must also bear the following statement: A mechanical system (probe and pump) must be used for transferring the contents of this container. If the contents of a non-refillable pesticide container are emptied, the probe must be rinsed before removal.

8. Exposure Controls/Personal Protection:

Ventilation Requirements:

Good local ventilation is required. Mechanical exhaust may be necessary if product is applied in an enclosed area.

Personal Protective Equipment:

CAUTION: Causes moderate eye irritation. Harmful if swallowed. Avoid contact with eyes, skin or clothing. When using this product, wear long-sleeved shirt, long pants, socks, shoes and rubber gloves.

After using this product, rinse gloves before removing, remove clothing and launder separately before reuse, and promptly and thoroughly wash hands and exposed skin with soap and water. Remove saturated clothing as soon as possible and shower.

This product is toxic to aquatic invertebrates. Drift or runoff may adversely affect aquatic invertebrates and nontarget plants. Do not apply directly to water.
